PROCEEDINGS OF THE EASTERN DISTRICT ASSOCIATION

Thursday Morning, October 4, 2012

The Eastern District Association of Primitive Baptists convened in its 160th annual session with Fairview Church, Bellbrook, Ohio.

Over 70 years ago people from various mountain sections of Virginia, Tennessee and Kentucky began to migrate to this area of Ohio as they sought a more prosperous way of life. Many found employment in industrial plants in this area and established their homes and farms in the vicinity.

Although they were enjoying their new homes and better means of earning a living, there was something not quite to their satisfaction. They visited various churches and sought to worship with them, but there was a spiritual atmosphere they had known previously that was missing from them here. They started having services in their homes, in groves or wherever a building could be found when weather conditions prevented them from meeting outside. As they enjoyed these services, a need for a church building of their own was felt.

The location where the church now is, and where an old church building had stood many years ago with an adjoining cemetery, was offered to them and arrangements were made for it to become the permanent location of a band of Primitive Baptist people. This was made possible with the help of "Uncle" George Driskel, who owned the land. Although he was a member of another organization, he was a true friend of this church.

The original building was erected and in August, 1938, the church was formally organized with the help of Elders E. A. Robinette, W. H. Burke, H. V. Hall and J. H. Sybert. The building was dedicated, and the first Union Meeting held. The church was admitted to the Eastern District Association in October, 1938, with 37 members on the roll.

The original 18 charter members included Brothers Orbin Barnett, Claude Barnett, Clyde Barnett, Jesse Barnett, Dewey Bledsoe, Hammie Fleenor, Lewis Joyner, Bryan Moore, Rhea Johnson, and Clarence Slagle; and Sisters Minnie Barnett, Hattie Barnett, Helen Barnett-Slagle, Lillie Bledsoe, Ollie Fleenor, Mary Gilliam, Euna Joyner and Mary Moore. These brothers and sisters have all gone on to be with the Lord.

The original building was remodeled and improved from time to time. The present building was completed and dedicated in November, 1965. The old building is presently being used as a Fellowship Hall. Present membership is 158.

Elder Clarence Slagle, who was the first pastor, served in that capacity the greater part of the time until 1976, and others who have served as pastor include the following: Elders Joe Dean, Frank Brown, Roland Callahan, Charles Roller, Luther Abrams, Bryan Moore, Elmer Parsons, Crawford Sage, Ron Bledsoe, Kenneth Mitchell, and Hasco Jenkins. Current pastors are Elders Jason Robinette and Joseph Robinette, his son and assistant.

The first Deacons included Brothers Orbin Barnett, Lewis Joyner and Bryan Moore, who all are at rest with the Lord. The influence from their guidance is still remembered and felt here. Others who have served as Deacons in the past were Brothers Owsley, Leonard Davis, Homer Lovins, Jim Osborne, Crawford Sage, Bobby Taylor, William Vanover, Kyle Vanzant, Ron Bledsoe, Kenneth

Mitchell, Emerson Browning, and Morris Giles. Current Deacons are Brothers Ray Eldridge and Eldon "Sonny" Wallen.

Brother Lewis Joyner was the first Clerk/Treasurer and served the church well until moving to Florida in 1966. The next Clerk was Sister Virginia Hall Osborne, daughter of Elder Hobart Hall, who served until her untimely death in January, 1974. Next was Sister Berneda Moore Vanover, daughter of Elder Bryan Moore, who served until 1979 when she moved to Tennessee. She was followed by Sister Betty Barnett Livingston, granddaughter of Brother Orbin Barnett, who served until 1982. She was succeeded by Brother Kenneth Mitchell, until his untimely death in 2002. He was succeeded by his wife, Sister Charlene Slagle Mitchell, who is still serving as Clerk, with Bro. Sonny Wallen as her Assistant.

In 1950 Sister Georgia Moore Sage, daughter of Elder Bryan Moore, was elected as Treasurer, and served well until her death in 2008. The current Treasurer is Betty Barnett Livingston, with Brother Keith Sage, son of Georgia Sage, as her Assistant.

Presently serving as Trustees are Brothers Eldon "Sonny" Wallen, Cleve Mitchell, Joseph Robinette and Lester Wayne Osborne. Trustees who served over the years include Brothers Orbin Barnett, Bryan Moore, Claude Baker, Harry Brown, Cleveland Slagle, John Osborne, Lace Maynard, Homer Lovins, Kenneth Mitchell, Ron Bledsoe, George Livingston, Morris Mounts, William Webb, Leonard Davis, Dewey Bledsoe, Sherman Cole, Dale Cole, Chuck Davis, Warren Kail and Eric Mitchell.

In the name of the Lord, we thank each of you here today and all those who have gone ahead of us to meet the Lord, for the strength and guidance you have given this church throughout the years.

The setting of this association is the 5th time the association has met with this church since it came to be a part of this body. We take this opportunity to offer our sincere thanks to all sister churches who have in any way assisted in preparing for this 160th annual session of the Eastern District Association of Primitive Baptists. May God's richest blessings be upon you.

For the 160th time, God's children met to worship and praise His holy name. Sister Zula McCullough led us in singing songs of praise to our Lord and Savior, Jesus Christ. What matchless love He showed to us with the anguish He bore. We all were sinking deep in sin and nothing else could help until His love lifted us out of the miry clay. There is wonder working power in the precious blood of the Lamb that makes us much whiter than snow. The unseen hand will lead us thru ways we cannot see; for as it leads we'll have no fear. We long to see our Master's face and some sweet day we'll reach that golden strand to praise Him for His guiding hand. There is a country to which we are going where there is joy without measure, for Heaven holds all. Keep your lamps all trimmed and burning; for the bridegroom watch and wait where we'll meet in the morning just inside the eastern gate. The joy of that glad meeting helps us consider His awesome wonder, and His power displayed throughout the universe as our soul sings to proclaim how great thou art!

Welcoming everyone to today's 160th gathering, Elder Terry Sizemore thanked God for all the blessings of this life asking everyone to let there be joy and love for the Lord. No one can welcome you like God. What have we come for today? We pray the response would be to witness to our people as they become aware of His presence and see our people saved.

Elder Sizemore mentioned the passing of Elder Bobby Williams since we last met. Another soldier has gone home, but we thank God for knowing him and being able to listen to his singing and

preaching of God's word. As time goes on, we must continue to carry the bloodstained banner for Christ until He calls us home.

The Letter Committee from last year consists of Bradley Bowen (chairman), Steve Minton, Ralph Baker and Billy Walton (alternate). The moderator asked the churches to turn in their church letters, obituaries, and financial contributions as soon as possible so the letter committee will have time to complete their review.

The moderator appointed the Committee on Religious Exercises which includes Dennis Stewart (chairman), Steve Hunt and Lloyd Morelock.

Elder Daniel Smith blessed us with his song and reminded us that God's presence disperses all gloom and takes us on high where winter and clouds are no more.

Elder Jason Robinette, co-pastor of the host church, welcomed everyone with his song and encouraging words. Somewhere in glory you'll find us singing and shouting throughout eternity. God's spirit will set us free, but from the church at Fairview, Ohio, Welcome! Welcome! Welcome!

Sister Zula led the congregation in singing the old song that is the association's standard song, "Brethren We Have Met Again." Are you waiting for your King, watching till He shall return? Brethren we have met to worship and adore our Lord; for all is vain unless the spirit of the Holy One comes down.

Elder Sizemore also asked that each minister and visiting minister in attendance at the association be sure to sign the minister's book located in front of the clerk's desk.

Brother Jim Bowlin humbly led us to the throne of grace.

Having been chosen to preach the introductory sermon, Elder Burnice Sybert took the first part of the service. After a wonderful testimony, he asked us to put aside everything except that of the Lord. Try the spirits to know if they are of God. Look at our articles of faith; knowing that every ordained minister and deacon was asked if they believed each one of them during their ordination service. We must believe what has been left to us, for we have a great heritage. Primitive means the original work and we believe our way to be the most like the original church. We are at the re-gathering, not a split. Our churches may be fewer, but our strength is not in numbers, but in our unity with God. Elder Sybert read Deuteronomy 32:1-7, II Tim 2:15, and a portion of verse 3 in Jude using as a thought, "Remember the days of old rightly dividing the word of truth and earnestly contend for the faith that was once delivered unto the saints." God will fight our battles today, just as He did in the days of Moses. They weren't wandering in the wilderness, but they were led by God because of disobedience. Those that followed God were able to go forth and take the land of the giants. Since Moses disobeyed, he was not allowed to go into the Promised Land. Many dear saints that showed us the way have gone home. Let us not run, but fight the fight in God's name. How much do you know about our history of the Eastern District Association of Primitive Baptists? What did our forefathers go through to establish this heritage we enjoy? Since the 1840's when the association was formed, we have reaped the benefits set forth in the early church. The church is the authority

that God works through. It is by this authority that we are led and our instructions are as clear as the day when Paul wrote to the church at Corinth. We should examine ourselves before we take part in the communion service to ensure we are a fit subject and of like faith. It is the will of God that all be saved. When He speaks to an individual, our prayer is that you heed this call and ask Him to save you. Our beliefs have not changed since the beginning.

Elder Scott Tipton followed with a song and another wonderful message. Take our hand precious Lord and lead us home. God's children know His voice and He is still with us. He has never, nor will He ever forsake us. Let us study and know what we have deep in our soul. Elder Tipton read Acts 4:23-31, asking that we speak the word of God with boldness. We do not need the help of the world because we have help from our heavenly Father. Love one another the best way possible with everything that is within us, but love the Lord with all our heart, soul, strength and mind. If we're led by His spirit, we are the sons of God. We must stick together in the ways of the Lord so our friends and family will follow in the path He has set before us. The Holy Spirit will not dwell in an unclean vessel; therefore, do that which is necessary to see our people saved.

We were dismissed for lunch with a song.

Thursday Afternoon, October 4, 2012

The church at Fairview served us a wonderful lunch as God's children enjoyed the beautiful sunshine. The old account was large and growing every day, but the record's clear today for the account was settled down on our knees long ago. To know that Jesus saved us is enough to endure the trials of this life. We will arise and go to Jesus where He will embrace us, for in the loving arms of our dear Savior there are ten thousand charms.

Further blessings were bestowed upon us with special singing and testimony from Terry and Peggy Sizemore. Many times we walk thru dark valleys and we don't understand, but some day we will stand on top of Mt. Zion and understand it all. We'll sing and shout when we reach that city.

Elder Sizemore welcomed everyone to the afternoon service; our eternal home is a great place to look forward to. From heaven He came, the sins of this world to atone. He showed us the way, then He got on a cloud and went home.

Prayer requests were made for the unsaved, all those made during the morning service, Tommy Meade's son and wife, lady in Circleville, our country and those serving our country and their families, John Turner, H. C. and Pearl Johnson, Kathy Robinson, Jim Brown, our churches, Michael Willis, Gordon Justice's family at the loss of his wife, and many unspoken requests signified by uplifted hands. Many wonderful testimonies were made throughout the tent. After a wonderful testimony, Elder Mike Fleenor took us to the throne of grace in a soul stirring prayer.

Brother Bradley Bowen, Chairman of the Committee on Church Letters, came forward to give the report of our state and standing. A total of 37 churches were recommended by the committee to be accepted. It was motioned, seconded and voted to accept the recommendations of the committee and seat those delegates duly elected or appointed by their respective churches as the voting body of the association. It was stated by the chairman, as churches may choose delegates from other churches, that it would be a good thing to change the church letter to read union instead of members.

Having just been accepted as the voting body, the motion was withdrawn until the association officials were elected.

The delegation was seated in order to conduct the business of the association.

The moderator asked for nominations to serve as moderator pro-tem during the election of the association officials. Elder Richard Seiber was nominated. It was motioned, seconded and voted by acclamation. It was motioned, seconded and voted for nominations to cease. Elder Seiber came forward to serve during the election.

After a wonderful testimony, the moderator asked for nominations to serve as clerk and treasurer of the association. A nomination was made and seconded for Brother Danny Lawson to serve as clerk and treasurer. It was motioned and seconded for nominations to cease. Through the vote by acclamation, he will serve for the ensuing year.

The moderator pro-tem asked for nominations to serve as moderator of the association. Elder Terry Sizemore was nominated and seconded for him to serve as moderator of the association. It was motioned and seconded for nominations to cease. Through the vote by acclamation, Elder Sizemore will serve as moderator for the ensuing year.

Elder Sizemore thanked Elder Seiber for standing as moderator pro-tem during the election of the association officials. With a vote to reaffirm the elections, Elder Sizemore thanked the delegation for their confidence in him.

Moderator Sizemore asked for permission to speak/comment as needed concerning our articles of faith. He then reviewed our articles of faith and asked each of us to review and recognize that through the Lord these are our foundation. The congregation listened as the moderator read the articles of faith, giving the scriptural references for each. Our churches and individuals agree to this each time they letter into this body.

The moderator asked for a motion and second to allow him to appoint all committees necessary to carry on the business of the association. It was motioned, seconded and voted to allow the moderator to appoint any and all such committees.

Brother Bradley Bowen, chairman of the Letter Committee, returned to the stand to discuss the changes to the church letter. It was recommended that the church letter be changed to reflect the fact that churches may choose delegates from other churches that are members in good standing of an Eastern District Primitive Baptist church. This would be accomplished by rewording a portion of the church letter concerning delegates sent to represent a particular "church" to include: "We have chosen the following named members of our church or association to sit with you in council..." This will allow any member in good standing with a sister church to serve as a delegate for said church. Likewise, the statement below the list of delegates would read: These members are in good standing and full fellowship with their respective church and we ask that you receive them... It was motioned, seconded and voted to have the clerk make the appropriate changes to the church letter.

The moderator reminded the delegation that Excused Absence forms are available at the clerk's desk.

It was motioned, seconded and voted to have all things which are standard printed in the minutes.

It was motioned, seconded and voted to allow the clerk to replenish the necessary forms to properly perform his duties.

It was motioned, seconded and voted to allow the clerk \$1500 in appreciation for his services.

The clerk reported all financial transactions during the year to the delegation.

It was motioned, seconded and voted to allow the moderator \$800 in appreciation for his services.

Brother Delmer McPherson, chairman of the Electrical and PA System Committee came forward to give their report. They are experiencing trouble with the new microphone purchased last year. Instead of buying a new one now, they are going to determine if it is still under warranty before purchasing another one. They are also experiencing trouble with the recorder, as it does not always record properly. If we are to continue recording the proceedings, does the delegation want them to purchase a new one? It was motioned, seconded and voted to allow them to use their better judgment to purchase what they need.

It was motioned, seconded and voted that the host church will be responsible for the maintenance of the kitchen, with any needed repair costs to be reimbursed by the clerk from association funds.

The clerk gave a report concerning the Ayers Chapel Church property. An appraisal of the property has been completed. A lawyer is preparing papers to obtain the deed to the property, including a formal search for the original deed. It was motioned, seconded and voted to allow the moderator, clerk, and Virginia trustees to handle the sale of the property.

The business being concluded, the delegation was dismissed until Friday morning, October 5, 2012.

Friday Morning, October 5, 2012

The Lord blessed us to gather for one more time this side of eternity. Sister Zula McCullough came forward to lead the congregation in singing several hymns of praise to our Lord and Savior. Prayer requests were made for the unsaved, all the requests from yesterday, those serving our country in the military, our association, our country, many wonderful testimonies were given thanking God for His blessings, Marie Mann, Daniel Hurd, John Turner, Mike Fullington, Clarissa Rose's family, Thelma Tankersley, ladies friend Teresa who suffered heart attack, Flo Minton and family, Jim Brown family, Kathy Robinson, and many unspoken requests signified by uplifted hands. Elder Jerry Johnson took our petitions to the throne of grace.

The delegation was called to order to transact the business.

It was motioned, seconded and voted to adopt the business proceedings of yesterday as read. It was motioned, seconded and voted to accept the changes to the church letter as recommended by the Letter Committee.

Elder Daniel Smith, having been chosen by the Committee on Religious Exercises, came forward to take the first part of the service. After a wonderful testimony he read I Corinthians 3:5-13 and Nehemiah 2:17 using as a thought, "Let us rise up and build." Times have changed, but God has not. No matter how many trials we face, just build on the foundation of God. When Jerusalem lay in waste as the walls were destroyed and the gates were burned, Nehemiah mourned because of all the troubles. We ask our Lord and He delivers in His own way at His own time. Don't worry about the things of this world, but lift up the name of Jesus. God has blessed throughout the existence of the association and will continue to do so. God is good today just as He has always been, so get back to the things of God. We may get knocked down, but God is on hand to help us up again. Our ministers must preach salvation to a lost and dying world to get back to the things of God. There is no place to quit, only to continue the work of the Lord. We have a weapon in Christ Jesus and we can still work for Him today. We are on a journey for the Lord; the gospel has not changed one jot or one tittle. Those that wait upon the Lord shall run and not be weary, and those who look unto the Lord knoweth from whence cometh all their help. We may not know of everything in this world, but we know of old time salvation by grace through faith. Drink from His fountain and you'll never thirst again. One may plant, another may sow, but only God gives the increase. Let whosoever cometh, drink of the water of life freely.

The congregation sang songs of praise as we were adjourned for lunch. God's amazing grace is sufficient for all our needs. The service didn't really break, it just moved over the grounds as shouts of praise and tears of joy were all around. Bless His holy name!

Friday Afternoon, October 5, 2012

The congregation assembled in the tent after a wonderful lunch served by the host church as everyone continued to praise the Lord. When our work here is done and our life's crown is won, we'll go to a land where we'll never grow old. In the sweet by and by, we will meet on that beautiful shore to draw nearer to our Blessed Redeemer. To our bountiful Father above, we will offer our tribute of praise and live throughout eternity.

We were further blessed with special singing and testimony from Amy Tipton Bledsoe, Kristi VanHoose Robinette, Moore family and Leona Kester. Just look around and see the good things He has done for us. His blessings are given freely and He has been so good to us; we owe it all to Him. We truly have so much to thank Him for. Regardless of how we may look, we are rich as a king. Even with a new garment that's never been worn or a mansion in glory; give me Jesus, for He is the

treasure that money can't buy. When you're in trouble and don't know what to do, just call on Jesus and He will carry you through and show you the way. God raised the waters in Moses' time and He will do the same for us, to allow us to conquer our giant. God in Daniel's time is still God today.

Elder Sizemore thanked the church for a bountiful and delicious lunch and thanked God for His spirit and the fact of knowing He is alive forevermore. Our Godly heritage is worth all our efforts. Respect the Holy Spirit that it remains with us always and know that He is a rewarder of them that diligently seek Him.

The Committee on Newly Constituted Churches reported that none had been received.

The Committee on Finance reported \$4,676.60 in receipts for the year. The chairman thanked each church and individual for their contributions. He mentioned that our finances were less this time and asked everyone to consider making an additional contribution to the association.

The Committee on Obituaries reported that 47 have been received at this time.

The Committee on Arrangements and/or Queries reported that no queries had been received.

The men chosen to write the circular letter for 2012 did not letter into the association this year. Elder Sizemore offered a reprint of the 1956 circular letter, if it would meet the association's approval. It was motioned, seconded and voted for him to read a preface he wrote, as well as the circular letter. The moderator read the preface and the circular letter of 1956 written by then moderator, Elder John H. Sybert. Its message was to strive for a time of peace, harmony and unity in our ranks brought forth through God's leadership back to the association's beginning. The history contained in this letter provides without any doubt exactly what our association believes. It was motioned, seconded and voted to print the preface and the circular letter in the minutes as read.

The moderator appointed the Committee on Circular Letters for 2013 which includes: Elders Greg Hill, Oscar Irvin and Roger VanHoose.

Elder Burnice Sybert came forward to address the association regarding the ordination of ministers and deacons. There is concern that ministers leaving our association might think they are covered by our association insurance. Since these ministers and deacons did not surrender their ordination papers, we need to provide legal notice concerning their standing with the association. Upon advice of legal counsel, he read a prepared letter and statement.

Following the annual gathering of the Eastern District Association of Primitive Baptists in 2011, which also serves as the annual meeting of the Eastern District Association of Primitive Baptists, Inc., the clerk wrote each of the churches which had formed a new association to request the Certificate of Ordination issued to their deacons be returned to the Association. He also wrote each minister whose membership was with these churches and requested they return their Certificate of Ordination. All refused to return them saying they had sought legal counsel and had been told they did not have to do so as an ordination could not be revoked.

Believing this statement to be incorrect, the Association then sought legal counsel, providing a copy of the Association Charter, a copy of the 2011 Minutes, a copy of the Certificate of Ordination for Deacon, and a copy of the Certificate of Ordination for Minister. Counsel confirmed that in the Eastern District Association of Primitive Baptists, ordination is only valid so long as the minister or deacon is a member of a church in the Association. The Certificate of Ordination is a binding legal contract between the local church (and Association) and the minister or deacon who is ordained. The Presbytery acts on behalf of the local church (and Association) and affixes their signatures to the document. The minister then signs the document with this oath: "In receiving this Certificate of Ordination, I hereby agree to conduct my moral and spiritual life in such a way as to promote peace and harmony in the church and association of which I am a member. I also agree that, if at any time I find that I cannot honestly and sincerely do so, I will return this Certificate to the Church and cease to be a member of this organization." The deacon signs with this oath: "I hereby agree to fill this office faithfully. When I can no longer do so I will immediately return this certificate of ordination." Both documents state plainly that the ordination is according to the rules contained in the Minutes of the Eastern District Association.

Counsel to the Association gave 2 options. Option 1 is to go to court and sue for the return of the certificates. The Association believes the instructions given by the Apostle Paul in I Corinthians 6 that a brother should not go to law against a brother, but that it is better to suffer wrongfully. We also believe ministers and deacons have a special obligation to honor their word, and had this been done, neither option would be necessary. Option 2 is to serve legal notice to the deacons by printing in the Minutes of the Association of 2012 the names of the churches which have broken covenant and withdrawn fellowship from the Eastern District Association, and, by printing their names in the Minutes of the Association of 2012, serve legal notice to the ministers that their ordination in the Eastern District Association is forfeited and all rights and privileges which were theirs as ministers in the Eastern District Association are also forfeited.

The clerk, by mail, shall also serve this notice by informing each church as agent for the deacons and the ministers individually of this action.

The following churches have either joined another association, stated by their own written word that they have withdrawn fellowship from the Association, or have failed to represent themselves for two consecutive years in the Association: Blair Chapel (Blair, KY), Butcher's Valley (Rogersville, TN),

Coyle's Branch (Gordon, KY), Guthrie's Gap (Bulls Gap, TN), House Chapel (Rogersville, TN), Hurricane Valley (Gordon, KY), Jenkins Chapel (Surgoinsville, TN), Liberty Chapel (Mt. Carmel, TN), Oak Grove (Bulls Gap, TN), Pilgrim's Rest (Rogersville, TN), Pink Hill (Surgoinsville, TN), Slate Hill (Mooresburg, TN) and Sulphur Springs (Rogersville, TN).

The names of the ministers and their church affiliation as it last appeared in either the Minutes of the Eastern District Association or a minute of another association which they have joined: Von Burton (Sulphur Springs), Glenn Cornett (Hurricane Valley), Phil Crittenden (Oak Grove), Russell Davidson (Jenkins Chapel), Neal Drinnon (House Chapel), Woodrow Fields (Blair Chapel), Fred Gilreath (Jenkins Chapel), Wayne Gulley (Guthrie's Gap), Greg Harr (House Chapel), Arry Hickman (Pilgrim's Rest), James Jarnigan (Slate Hill), Jamie Jarnigan (Slate Hill), Robert Jarnigan (Slate Hill), Adam Justice (Sulphur Springs), Gordon Justice (Pilgrim's Rest), Larry Miller (Guthrie's Gap), Roger Purkey (Slate Hill), Rod Raleigh (Blair Chapel), David Smith (Pilgrim's Rest), Stacy Smith (Guthrie's Gap), Richard Watts (Pink Hill) and Bill Winstead (Sulphur Springs).

It was motioned, seconded and voted to print these recommendations and for the clerk to send the letter to each minister and church clerk for notification of the respective church deacons.

To the churches that did not letter in this year, a letter to warn of some possible pitfalls is as follows: The Association, while not understanding what any church hoped to accomplish by not lettering to the Association, believes it is necessary to warn the churches which chose not to do so of some possible pitfalls. As it has already been stated, ministers and deacons who are not members of a church represented in the Association have no legal rights to exercise that office. This especially applies to being a pastor and conducting church business and to officiating in weddings, depending on the laws of each state.

Each church should also consider the consequence if the need arises for a new pastor. The ministers of the Eastern District Association of Primitive Baptists are only licensed to pastor and conduct the ordinances of a church which is in the Association. If the church wishes to have a union meeting, with whom is the church united or in union?

Therefore it is advised the Association grant a year of grace to those churches which do not join another association, but for whatever reason failed to letter in this year. The ministers names will not appear in the Ministers List, but the Association will not call for their credentials if the church where they hold membership letters in 2013.

If a letter is not received in 2013, the same action taken this year with the 13 churches will also be forthcoming.

If there are members of any church which left the fellowship of the Association who desire to continue as a member church in the Association, the Association may well consider them to be the true church and provide them with all help possible.

The Association offers this advice in love and desires to continue to fellowship with all churches which do not deviate from our faith and practice as stated in the Articles of Faith, Rules of Decorum and Church Covenant.

It was motioned, seconded and voted to follow these recommendations, and make them a perpetual procedure.

Elder Sybert made the delegation aware of the issues involved with churches, dealing with how churches are deeded. There is a legal process to amend a deed to state if it ever ceases to be a member of the Eastern District Association of Primitive Baptists, then the church property would revert back to the association. It was motioned, seconded and voted for the Virginia, Kentucky and Tennessee trustees to check the official deed of record of those churches not lettering into the association or having joined another association to determine if they can leave the association according to official records on file in their respective state.

Each minister and pastor must stand for truth and let their members who may have questions know exactly what has happened during these trying times. Answer their question truthfully and if you don't know the answer, seek the proper council of God and your fellow ministers.

The moderator reminded those serving on the committees that they were released when their final report is given.

The greatest news of any association meeting is to see a lost soul come to know the Lord. Today we were blessed to know that a young lady accepted Christ as her personal Savior. No greater news can ever be told, bless the name of the Lord!

The moderator reminded the delegation that only those chosen or appointed by their respective churches as delegates were allowed to vote. There were 3 churches that asked for the association to meet with them next year. These are: Blackwater Lick, Clear Springs and Richardson Chapel. Before the plea process began, Richardson Chapel withdrew. During the plea process, Clear Springs withdrew, sending the association to Blackwater Lick (Big Door) Church where the Lord willing we will convene on Thursday morning, (October 3, 2013) before the first Saturday in October, 2013. Introductory – Elder Daniel Hurd, Alternate – Elder Porter Carroll.

Adjourned until Saturday morning, October 6, 2012.

Saturday Morning, October 6, 2012

After a rainy night, the beautiful sunshine greeted everyone as they gathered in the church for the memorial service. There was no charge for the attorney for his help with reviewing the association paperwork, but the clerk will send a letter of thanks to the attorney for his help.

The clerk read the Resolution of Thanks that he had prepared. It was motioned, seconded and voted to print it in the minutes as read.

For many years, the Saturday service has been dedicated as a memorial service for those saints who have passed from among us. As a special quiet fell over the church, the moderator read the list of names of those that have left our ranks since we last met. These dear saints have gone on to their reward, but they left us with many memories. These memories are precious in our hearts, but we know they are at peace with our Lord.

Having been chosen by the Committee on Religious Exercises, Elder Harold Shaw took the lead of the service, singing a song and giving a wonderful testimony. CIRCULAR LETTER

Fifty six years ago, the Eastern District Association of Primitive Baptists was meeting the first time after the year commonly referred to as "the split." There are those of you among us that remember this gathering first hand. I must admit I can only speak to this time from conversations I've had with many of you that were there. The Circular Letter that was written that year was one that I can echo in sentiment and in fact. It seems that change is inevitable in this world we live in. We have again gone through what some would describe as "a split." Suffice it to say, I wish this was not the case. Thankfully, we have a great Provider! He will never fail us. Praise His Holy Name! He will never leave us.

As suggested by the Circular Letter Committee of 1956 to allow the beloved Moderator of that time, Elder John Henry Sybert, to use the letter he had composed as the circular letter, I feel this letter very aptly applies today as well as then.

The appointed committee for this year's letter was composed of men whom have since left us; therefore, I recommend we re-print the letter of 1956 as recorded in our minutes.

During the course of time in which I have served by will of the delegates assembled, as Moderator of the Eastern District Association, I am confronted with the various problems which concern the welfare of our churches, ministers, and people in general.

My advice is sought from time to time on these matters as, I suppose, has been the case with all my predecessors in this position.

Trying to serve as Moderator does not, of course, make one an authority on these matters and the advice or help I attempt to give is unofficial when the Association is not in session.

Thinking of the great spiritual need and understanding that is needed among our people, as well as all others, I have herewith attempted to set down some thoughts and explanations, which if approved by the delegates of the Association, would form something of an official attitude concerning the matters I will try to discuss.

Some of the misunderstanding seems to hinge around the question of what relation the individual churches have toward the Association or what powers the churches and Association have in respect to each other.

It is, no doubt, well understood that the local individual church is the first and all-important organization in regard to carrying on the Great Commission and work assigned it by the Lord Jesus. Its government is democratic, its officers those of scriptural authority (pastor, and deacons) with others, such as the clerk, as may be found useful by the church; its purpose to be the light of the world; its aim to contend for sound Bible doctrine and practice regardless of all that may be said or done to the contrary.

It is true, doubtless, that churches existed and functioned many centuries without associations as we now know them being formed. It may then well be asked why we have associations. This may be difficult to answer or many different opinions might be given, but I shall attempt to give as best I can the purpose and goal of the Eastern District Association and its relation to the churches that compose it.

Down through the ages, many false and unscriptural doctrines and practices have arisen among the professed followers of Christ. These, of course, continue and increase as time goes by. Having failed to subdue the church by persecution and force, Satan also uses the means of imitation, substitutions and change to cause division in our ranks and to weaken the true Spirit and power of God among His people.

In the organizing of the Eastern District Association it was felt, as we believe, by our forefathers in the church that a union of churches, agreeing on the great fundamental principles of truth and righteousness, could be a greater strength and influence for good than could independent, isolated churches trying to work alone. As a result, the great truths as they believed and understood them, were set down as what we now have as the Articles of Faith, Church Covenant, and Rules of Decorum.

These statements are not the rash or hurried opinions of men with malice in their hearts but, as they understood them, the plain teachings of the New Testament with the background of the history of the churches that endeavored to follow this unadulterated teaching in the face of tremendous odds.

The Eastern District Association has therefore endeavored to point the way of true simple Bible doctrine and practice without attempting to copy from other organizations or institutions that tend to be of a carnal nature.

It has been the desire of the Association to leave the individual churches free to manage their own affairs and business so long as the church endeavored to stay in line with the true principles upon which we are founded

I mention here and now a few of the points that have at some time or other caused controversy among our people.

In the interpretation of our doctrine as we understand the Scriptures to teach, the Association has contended for and advocated, the eternal security of the believers, the Trinity of the God Head, closed or restricted communion to those believers in Christ only who are willing to accept the doctrine and practice of the church by becoming members prior to receiving or taking part in the communion service and the rejection of both the doctrine of limited atonement and universal salvation or no eternal punishment for the wicked, but we believe that the life, death, and resurrection of Christ gave all people the opportunity to be saved and those that believe in Christ shall be saved and those that believe not shall be damned.

The Association also provides a means by which letters of recommendation can be exchanged between churches for members who for reasons of convenience desire to move their membership from one church to another; it provides a means by which pastors and evangelists may be contacted and secured by different churches from the membership of other churches in the union. Union meetings and special services by visiting ministers, when desired, are also an example of the benefit and cooperation that may be obtained and enjoyed by the various churches in the union.

If proper regard to peace and harmony is exercised by our ministers and churches in general, then we should be uniform in our belief in and practice of the main fundamental points of our churches and Association.

There now seems to be an effort being made to discredit the Association and the principles for which it has stood these many years.

There seems to be those who are more interested in gaining popularity, fame, and in some cases a life of ease and leisure than to have the courage to contend for the original doctrine and practice of the Apostolic churches.

It is being falsely reported that the Association is against Christian teaching and study of the Scriptures; that it is opposed to the care and support of the poor: that it does not advocate any financial support of pastors or ministers. It is said that we do not believe in being progressive and in keeping up with the times.

As I attempt to answer these charges, I want to point out that the Association does not consider itself as some super police force going around trying to enforce cruel, selfish, or unscriptural doctrines or practices on any church, minister or individual.

I have found in a small amount of study and research that the Association desires to leave to each individual church the ways and means by which it may best carry out the principles upon which each church is founded.

As for the Association being against any form of true Bible study or growth in Christian knowledge, I find this rather to be encouraged in the Church Covenant which the Association endorses and advocates for all the churches. There are, however, no boards or committees set up by the Association to force any church to fall into a certain pattern in regard to how often or what form of services they may have.

In former days when churches had fewer services, there was a great amount of visitation between the churches, which was of great strength and comfort to all concerned.

Yet if the church feels the need of extra services, they should be bound only by the true desire to advocate the doctrine of Christ and not lean to any doctrines or theories of men.

We say again in the Covenant that we will cheerfully contribute of our property for the support of the poor and the maintenance of a faithful ministry of the gospel among us.

Again this is for the individual church to decide just what means they may use to carry out the true spirit of this Covenant. The Association has stated from time to time that any church that so desires may have a treasury with the deacons in charge to investigate and recommend all cases of needy circumstances in order that the church may perform its duty. The church should also support the pastor in regard to his expenses and other such help as may be possible or advisable. The minister should at all times remember the true purpose of his calling and not be influenced by the possibility of financial gain, to the neglect of his duty to those churches and congregations that are less able to support him.

As to the preceding mentioned doctrines and all the real teachings of the Scriptures, the Association feels that all churches and ministers are duty and honor bound to teach, preach, and practice so as not to cause trouble or discord in the Association body as a whole so that all may be able to behold how good and pleasant it is for brethren to dwell together in unity.

I should also like to add that the Association has provided through a Committee on Arrangements or Queries a means to discuss and attempt to answer any questions that may be brought before the body, and before wild and rash statements and charges are made against the Association, this means of obtaining the true opinion of the Association should be used.

Then in summary, I say that the Association does not intend to meddle in one way or another in those things which are the material rights of each church, but it is hoped as delegates from various churches gather at the Association from year to year, that it may be as a multitude of counselors wherein there may be pointed the way of safety in regard to the great heritage of earnestly contending for the faith that was once delivered to the saints.

We therefore recommend no man-made bonds or institutions to promote this great cause, but urge that each and all search diligently from the depth of heart and soul that they may be guided by

the great spirit of truth as it unfolds to us the true teaching of God's word. In so doing, we will find that our Great Shepherd will make a way where ever He bids us go or asks that we do.

As we go forth, may we boldly yet with all humility mind and spirit teach, preach, and advocate these things wherein we have been blessed by the Lord in the past, at the same time reconciling ourselves to the fact that such as do so have always been in the minority and that we shall have much criticism to endure from many around us.

May we endure this patiently, and live soberly, righteously and godly, putting away malice, wrath, hatred, lying and all such works of the flesh so that God may bless us with power that sinners may be saved and His people come to the unity of faith, is the prayer of your unworthy servant.

PROCEDURE FOR ORGANIZING NEW CHURCHES

(Revised 1964)

- 1. Obtain an arm from the nearest sister church when practical. This arm must be chosen at a regular business session of the church and should consist of no less than seven members; three of whom should be ordained members.
- 2. When the arm arrives at the designated place, a moderator and clerk pro-tem shall be chosen after which the moderator shall call the council to order and have the clerk read the Articles of Faith, Church Covenant, Rules of Decorum and Church Constitution. These must be adopted and written in the church book.
- 3. The moderator shall ask for those who wish to become members of the church, and they shall be received in the manner approved by the Primitive Baptist Church. Should there be less than seven, they shall remain under the watchcare of the church from which the arm was obtained. This church shall be

required to appoint such members as may be necessary to transact business. These members shall be required to be present at each regular church session until the new church becomes a body of at least seven members.

- 4. A pastor and clerk shall be elected at this time, and when practical, at least one member shall be chosen to prove himself for the office of deacon.
 - 5. A name shall be given the church and their regular meeting time declared.

PROCEDURE FOR ORDINATION OF MINISTER OR DEACON

(Revised 1964, 1970, 1983, 1988, 2005, 2006, 2010, 2011)

Any person being considered by the church for the Ministry or the office of Deacon must be set apart by the church to prove himself as to his calling and qualifications for as long a time as the church may deem necessary.

In order to better acquaint both the presbytery and the local church pertaining to the qualifications of a minister and deacon, the past records have been thoroughly searched. There may have been many ideas, opinions and much discussion; however, the records are the only official means we have of knowing where the association stands and the action it has taken.

(A) We believe the only power that can qualify a person to preach the gospel is the Spirit of God, and no educational institution can qualify a person to preach the gospel.

(Adopted at Blackwater, Tennessee – 1881; published 1970)

(B) We advise the churches to be careful in the ordination of ministers and deacons in order that they observe gospel order. (See Paul's instructions to Timothy and Titus.)

(Adopted at Piney Grove Church – 1886; published 1970)

(C) How shall ministers from other associations be received into the Eastern District Association?

Answer: Any minister of any other organization desiring to become a member of any of the association churches as a minister: (1) shall first be received as a member of a local church; (2) the church then at their discretion shall set him aside to prove himself; (3) when the church is fully satisfied, they shall proceed to ordain him according to our rules.

(Adopted at Blackwater Lick Church – 1978; published 1988)

(D) Is it proper procedure for the ordained deacons and elders of the Eastern District Association to participate in ordination of brethren from other churches or church organizations that have not joined our membership?

Answer: No, an ordained deacon or minister of the Eastern District Association of Primitive Baptists has no authority to serve on the presbytery for the ordination of someone outside the association.

(Adopted at Riverside Church – 2005; published 2005)

(E) Resolved, that the ministers and deacons of the Eastern District Association of Primitive Baptists shall not officiate or participate in the marriage between two men or two women; neither will any who engage in a lifestyle contrary to the teaching of the Scriptures as recorded in the King James translation of 1611 be accepted as a minister or deacon in the Association.

(Adopted at Flower Gap Church – 2006; published 2006)

- (F) Requirements or Qualifications for Ordination Procedures for Ministers or Deacons (Titus 1:6-9). If any be blameless, the husband of one wife, having faithful children not accused of riot or unruly. For a bishop must be blameless, as the steward of God; not self-willed, not soon angry, not given to wine, no striker, not given to filthy lucre; But a lover of hospitality, a lover of good men, sober, just, holy, temperate; Holding fast the faithful word as he hath been taught, that he may be able by sound doctrine both to exhort and to convince the gainsayers.
- (I Timothy 3:2-7). A bishop then must be blameless, the husband of one wife, vigilant, sober, of good behaviour, given to hospitality, apt to teach; Not given to wine, no striker, not greedy of filthy lucre; but patient, not a brawler, not covetous; One that ruleth well his own house, having his children in subjection with all gravity; (For if a man know not how to rule his own house, how shall he take care of the church of God?) Not a novice, lest being lifted up with pride he fall into the condemnation of the devil. Moreover he must have a good report of them which are without; lest he fall into reproach and the snare of the devil.
- (I Timothy 3:8-13) Likewise *must* the deacons *be* grave, not doubletongued, not given to much wine, not greedy of filthy lucre; Holding the mystery of the faith in a pure conscience. And let these also first be proved; then let them use the office of a deacon, being *found* blameless. Even so *must their* wives *be* grave, not slanderers, sober, faithful in all things. Let the deacons be the husbands of one wife, ruling their children and their own houses well. For they that have used the office of a deacon well purchase to themselves a good degree, and great boldness in the faith which is in Christ Jesus.

(Adopted at House Chapel Church – 2011; published 2011)

When the church is satisfied concerning the candidate for ordination and has voiced their approval of him, then at an appointed time the ordination is to be carried on in the following manner:

- A Legal Presbytery is appointed which shall consist of not less than three nor more than seven ordained men, one of whom should, if possible, be an ordained deacon in the church in which the ordination is taking place. In case only three are used to compose the Presbytery, two ministers and one deacon, or two deacons and one minister, may be used.
- 2. The church presents the candidate for ordination to the Presbytery for examination. Each member of the Presbytery will have ample opportunity to question the candidate concerning his calling if to the ministry, also concerning his moral and spiritual qualifications and particularly to his understanding and belief of the Articles of Faith, Rules of Decorum and other principles of the church.
- 3. When the Presbytery has completed their examination of the candidate, they return him to the care of the church with their report.
- 4. If the report of the Presbytery is satisfactory and the church is satisfied, they express their approval and return the candidate to the hands of the Presbytery for the ordination.

5. The Presbytery with prayer and laying-on of hands ordain the candidate. A charge is given by one member of the Presbytery. A Certificate of Ordination may then be given with authorized signatures.

CHURCH COVENANT

Having been, as we trust, brought by the grace of God to embrace the Lord Jesus Christ, and to give ourselves wholly to him, we do solemnly and joyfully covenant with each other to walk together in Him in brotherly love to His glory as our common Lord. We do therefore, in His strength engage that we will exercise a mutual care as members one of another to promote the growth of the whole body in Christian knowledge, holiness, and comfort to the end that we may stand perfect and complete in all the will of God, and to promote and secure this object we will uphold the public worship of God, and the ordinances of His house, and hold constant communion with each other therein. That we will cheerfully contribute of our property for the support of the poor, and for the maintenance of a faithful ministry of the gospel among us, and that we will not omit family religion at home, nor allow ourselves the too common neglect of the great duty of training our children and those under our care with a view to the service of Christ and the enjoyment of heaven. That we will walk circumspectly in the world that we may win their soul; remembering that God has not given us the spirit of fear, but of a sound mind, that we are the light of the world, and the salt of the earth, and as a city set on a hill. That we will frequently exhort, and if occasion requires it, admonish one another according to Matthew 18; in the spirit of meekness considering ourselves, lest we also be tempted, and that as in baptism, we have been buried with Christ, and raised again, so there is on us a special obligation, thenceforth to walk in newness of life, and may the God of peace who brought again from the dead, our Lord Jesus, that great Shepherd of the sheep, who through the blood of the everlasting covenant, make us perfect in every good work, to do His will working in us that which is well pleasing in His sight through Jesus Christ, to whom be glory forever and ever. Amen.

CHURCH CONSTITUTION (Especially for Newly Constituted Churches)

We do, with mutual consent, agree to embody ourselves together as a religious body to worship God. Being a church congregated, we hold and teach:

Baptism of believers in Christ by a decent immersion of our whole bodies once in water;

The final perseverance of the saints;

The resurrection of our bodies;

A restricted communion to church members in full fellowship;

The Old and New Testament Scriptures (King James Version) to be the revealed will and mind of God;

The Christian Sabbath to be a holy and heavenly institution;

That we should not forsake the assembling of ourselves together as the manner of some is, and especially our regular church meetings should diligently be attended;

That we should not expose the infirmities of our members except in gospel order;

That we should not move out of the bounds of the church without applying for a letter of dismission;

And that we should communicate of our worldly substance for the decent support of the church and ministry.

With this mutual consent and understanding, having been duly and properly organized, constituted, and pronounced a church, we are ready, by the will of God, to proceed to business.

(Revised in 1959)

RULES OF DECORUM

Ordered, therefore that the following decorum be a rule for the church to conduct herself by in future conferences. See Nehemiah 10:39.

- 1. Conference shall consist of members of the church and visiting members of sister churches of the same faith and order if so desired.
- 2. Conference shall be opened and closed with praise and prayer to Almighty God. I Tim. 2:1; I Thess. 5:17, 18.
- 3. One shall be chosen to preside, who shall be addressed under the appellation of "Brother Moderator," to whom every speech shall be perfectly directed.
- 4. The members' names being regularly enrolled shall by the Clerk be distinctly called over.
- 5. A door shall be open when thought necessary for admission of new members into the church. But none shall be admitted but by unanimous consent, and shall first verbally relate their experience and give an account of the work of God in their hearts; and secondly, of their faith and principles, if the church requires it; and thirdly, the church shall make diligent inquiry respecting their moral conduct. When full satisfaction shall be obtained, the Moderator shall manifest the same by giving the right hand of fellowship and thus receive them in order.
- 6. No complaint shall be brought in the Conference respecting crimes of a private nature until the grieved party has complied with the directions of our Lord in Matt. 18:15.
- 7. Every motion and second shall come under the consideration of the Conference unless withdrawn by the member who made it.
- 8. Every query presented shall be three times read. When it is read, the Moderator shall put it to a vote to see if the majority is for or against answering it. The query shall be debated if deemed necessary, but the querist may withdraw it any time providing that no intricate question be asked.

- 9. If the minority at any time should be grieved at the determination of the majority, they are hereby directed to make the same known immediately to the church; and if satisfaction cannot be obtained, it may be necessary in that case to call for help from sister churches.
- 10. Section 1. All business of the Conference shall be recorded by the clerk before the conference rises; the same shall be distinctly read and corrected, if need be.
 - Section 2. Any member neglecting to attend conference, the same shall be disorder.
 - Section 3. Any member absenting himself or herself from conference without leave, the same is disorder.
 - Section 4. Any member whispering or laughing in time of public speech, the same is disorder.
 - Section 5. If two or more shall speak at one time, or any member speak without rising and addressing the Moderator, the same shall be disorder.
 - Section 6. Any member speaking more than three times on any subject without leave obtained, the same is disorder.
 - Section 7. Any member, grieved at anything done in conference, and shall hold his or her peace, and shall not let the same be known until conference rises and shall afterward speak of the same, as it manifestly tends to confusion, is hereby deemed disorder.
 - Section 8. Any member speaking or acting in wrath or anger, or in threatening or disregarding manner, as it shames religion, wounds the cause of Christ, and grieves the true Christian, is hereby deemed disorder.
 - Section 9. If any moderator shall neglect plainly and calmly to reprove any member transgressing these rules, or behaves in any manner irreverently in the time of conference, the same is disorderly in him, and himself, for the time, liable to be reproved.
 - Section 10. The woman hath not the right by the law of Christ to usurp authority over the man, and therefore ought not to speak in church, only in case of conscience, or in such particular circumstances that the nature of the case may require it.
 - Section 11. Amendments to these rules may be made at any time when the conference shall deem necessary.

ARTICLES OF FAITH

- 1. We believe in one true and living God as revealed in the Bible and the Holy Trinity by the name of The Father, Son and Holy Ghost. I John 5:7.
- 2. We believe the Old and New Testament Scripture, as recorded in the King James translation of 1611, to be the written and revealed Word of God. II Tim. 3:16; II Pet. 1:20, 21.

- 3. We believe God created the heaven and the earth and all things therein. Gen. 1:1; Col. 1:16, 17; Rev. 4:11.
- 4. We believe God made man of the dust of the earth, and He made him good and He gave him a law to keep and man transgressed the law and fell from his first estate and lost his righteousness. Gen. 1:27, 2:7, 2:16, 17, 3:6-23.
- 5. We believe in the total depravity of man, that he was unable to redeem himself from the fallen state he was in. Gen. 3:24; Rom. 5:9-19.
- 6. We believe God so loved the world that He gave His only begotten Son to be the propitiation for the sins of the world, that whosoever believeth in Him should not perish but have eternal life. John 3:16; I John 2:2.
- 7. We believe sinners are justified by faith and saved by grace. Eph. 2:8; Rom. 5:1, 2.
- 8. We believe the Gospel is the only means God has ordained by which sinners are brought to Christ. I Cor. 1:21-24.
- 9. We believe he that believeth in the Son of God hath the witness in himself. I John 5:10.
- We believe baptism, the Lord's Supper, and feet washing are ordinances of Jesus Christ given to the church by example and command for us to observe until He comes again. Matt. 28:19; John 13; I Cor. 11:23-26.
- 11. We believe the only scriptural mode of baptism is by immersion of the whole body in water in the name of the Father and of the Son and of the Holy Ghost, and believers are the only fit subjects for baptism. Rom. 6:4; Col. 2:12; Matt. 28:19.
- 12. We believe all the saints will persevere through grace and never fall away. Eph. 1:13, 14; I Pet. 1:5; John 10:28, 29.
- 13. We believe in election according to the foreknowledge of God and the sanctification of the Spirit through the belief of the truth. Eph. 1; I Pet. 1:2, 3.
- 14. We believe the church is the light of the world and is made manifest by keeping the commandments and examples of Jesus Christ, who is the Head of the church in all things. Matt. 5:14; Eph. 1:22, 23.
- 15. We believe God chooses, calls and qualifies those whom He would have to preach the gospel, and God has promised temporal support of His ministers. Rom. 10:14, 15; I Cor. 1:25-29; I Cor. 9:7-11.
- 16. We believe in a restricted communion confined to the church in fellowship, walking in the light and observing gospel order. I Cor. 5:11, 12; John 13; I Cor. 11:31, 32.
- 17. We believe Christ is the only lawgiver in Zion, and the New Testament scripture is perfect, a thorough furnisher to the man of God unto all good works. James 4:12; Il Tim. 3:16.
- 18. We believe Jesus Christ, during the time of His earthly ministry, set up a spiritual kingdom on earth, in fulfillment of Old Testament prophecy; He being the King and all born again believers the subjects

- of the Kingdom, and they are now reigning with Him as Kings and priests on the earth. Dan. 2:44; Isa. 9:6, 7; Matt. 3:2; Luke 17:20, 21; John 18:36; Rev. 1:5-7.
- 19. We believe God hath appointed a day in which He will judge the world in righteousness by His Son, Jesus Christ, and this day will be after the death of the body. Heb. 9:27; John 5:22; Acts 17:31.
- 20. We believe there will be a general resurrection at the last day, both of the just and the unjust; this will also be the day of final judgment and the eternal destiny of all people, of all ages, will then be made known. Acts 24:15; John 5:28, 29; I Cor. 15:23, 24, 54; I Thess. 4:14-17; II Thess. 1:7-10.
- 21. We believe the punishment of the wicked is everlasting and the joys of the righteous are eternal. Matt. 25:46.
- 22. We believe God instituted marriage as the union of one man and one woman as husband and wife and any other such union is an abomination. Gen 2:18-25; Lev. 18:22; 20:13; Rom. 1:24-32; Eph. 5:22-33; I Pet. 3:1-7.

ASSOCIATION CONSTITUTION

- 1. This Association shall be called "The Eastern District Association of Primitive Baptists."
- 2. The Association shall be composed of members chosen by the different churches in our union, and producing letters from their respective churches shall be entitled to seats.
- 3. In the letters from the different churches shall be expressed the number in fellowship and gains and losses since the last Association.
- 4. The members chosen and convened shall have no power to lord it over God's heritage, neither any clerical power over churches, nor shall they infringe upon the material rights of any church in the union.
- 5. The Association, when convened, shall be governed by a regular and proper decorum.
- 6. The Association shall have a moderator, clerk and treasurer, who shall be chosen by the suffrage of the members present.
- 7. New churches may be admitted into the union by letter and delegates; and if found orthodox and orderly, shall be admitted into the Association and manifested by the moderator giving each the right hand of fellowship.
- 8. Each church shall be entitled to one and not more than four representatives in the Association.
- 9. Each query presented by any church to the Association, being first debated in their own church, shall be taken up by the Association.
- 10. Each motion and second shall come under the consideration of the Association, except it be withdrawn by the member who made it.

- 11. The Association shall furnish the churches with Minutes of the Association.
- 12. We think it necessary to have an Association fund for defraying expenses, for the raising and supporting of which it shall be the duty of each church in the union to contribute such sums as they may deem proper and send it by the hands of their delegates to the Association.
- 13. There shall be an Association book kept wherein the proceedings of the Association shall be recorded by the clerk, who shall have a compensation for his trouble.
- 14. The Minutes of the Association shall be read and corrected, if need be, and signed by the moderator and clerk before the Association rises.
- 15. Amendments to this form of government may be made at any time by a majority of the union, if they deem it necessary.
- 16. The Association shall have power to provide; first, for a general union of the churches; second, to preserve inviolable a chain of communion among the churches; third, to give the churches all necessary advice in matters of church difficulty.
- 17. The Association shall have power to inquire into the cause why churches fail to represent themselves at any time in the Association.
- 18. The Association shall have power to appropriate the money contributed by the churches to any purpose it may think proper.
- 19. The Association shall have power to appoint any member or members to transact any business it may deem necessary.
- 20. The Association shall have power to withdraw from any church that violates the rules of the Association or deviates from the principles of orthodox religion.
- 21. The Association shall have power to admit any orderly minister of our order to a seat in the Association.
- 22. The Association shall have power to adjourn to meet at any future time or place it may deem proper.
- 23. Each church shall endeavor to have its letter and delegates present on the first day of the Association. Any church not represented at that time shall report to the committee on letters giving their reason for delay.
